AgriSearch Chairman's Report



The remit of AgriSearch is to commission research that has the potential to provide with dairying, beef or sheep enterprises. The trustees also make some funds available to assist in the dissemination of the results of that research for the benefit of the farming industry. The aim is to reduce costs of production, improve performance and increase the welfare of animals and farmers. Funding is obtained through 'terms of trade' levies, collected from Northern Ireland farmers by processors of milk, cattle and sheep and passed on to AgriSearch. Original intentions to have levies collected on animals sold through livestock markets in Northern Ireland have not been implemented

Levy rates are 0.02p/litre of milk processed; 20p/head of cattle and 5p/head of sheep slaughtered in NI plants. With no increase in these rates since they were first set in 1997, the income of AgriSearch per unit of production is declining in real terms.

A decrease in income has also resulted from recent reductions in Northern Ireland's farm output of milk, beef and sheepmeat. During the year to 31 March 2009, these reductions have directly resulted in a fall of £17,500 (4%) in AgriSearch levy income, when compared to the previous year.

The investment income of AgriSearch was down by £40,000 (almost 40%) in 2008/09. This was partly due to falling rates of interest but also because the previous year's figure had included income from the maturation of a three year bond.

With uncertainties about the security of some banking organisations during the past year, the trustees have been alert to the risk of loss of any funds held. Options outside standard deposit accounts are being used as part of a spread of investments, within a continuing policy of 'low risk'. The trustees aim to maintain their policy that the investment income fully covers the administration costs of AgriSearch, so that all of the money collected as levies is expended on research and its dissemination. Administration costs are under scrutiny.

During the 2008/09 financial year, £537,354 was committed to 8 research projects. These are listed on page 5 of this annual report. The money is to be drawn down over a period

of months or years as the related research proceeds. One previously approved project is not going ahead and this resulted in £77,713 being recredited to our accounts.

Since 1997, just over £5m levy income has been collected, of which £414,000 has come in during 2008/09. Over £4.6m has been assigned to research, in a total of 77 projects supported. With complementary funding, mostly from the Department of Agriculture and Rural Development, this has resulted in overall investment of more than £12m in projects backed by AgriSearch. In February 2009, Dr Sinclair Mayne was appointed as Departmental Scientific Adviser (DSA) at the Department of Agriculture and Rural Development. This appointment has been welcomed by AgriSearch. It is expected that, with the DSA in post and with the publication of the DARD Evidence and Innovation Strategy in July 2009, there will be clarity in the future direction of agricultural research priorities. As a result, the basis for allocation of complementary funding should become much more clear and decisions on the approval of projects and allocation of that funding should not suffer the delays that were a feature of recent years.

Personnel

The past year has seen considerable turnover in personnel at the Northern Ireland Agricultural Research and Development Council (AgriSearch).

Bill Yarr stood down from the position of chairman on 23 February 2009, after almost ten years at the helm. Bill has given outstanding leadership and has left AgriSearch with robust systems of governance in place.

Since my appointment as vice chairman in September 2004, I have been privileged to witness Bill's meticulous and thorough approach to the job. I believe that all of the trustees who served during his chairmanship have great respect for the manner in which he operated. On behalf of all of them and all members of the advisory committees, I wish Bill well in his retirement. In October 2008, Mervyn King and David Workman were appointed as 'independent' trustees and David was subsequently elected as vice chairman on 23 February 2009. Also in February, Seamus Haughey and Ian Marshall became trustees. Ian replaced Gary Hawkes as a nominee of the Ulster Farmers' Union, on whose behalf Gary had served since May 1999. Seamus took over as an independent farmer representative from Peadar Montague, who had been involved since the setting up of the Council in 1996. I wish to record the wholehearted appreciation of AgriSearch for the contribution that Peadar and Gary made as trustees over such a long period.

Sincere appreciation is also due to James Walker, who served as a nominee of the dairy processing sector (levy collectors) from September 2006 until his retirement in March this year. John Dunlop was appointed in June 2009 to fill the vacancy.

The appointment of Mary McCormack as an independent farmer representative in June 2008 was reported in the chairman's statement last year.

Mary replaced Wilfred Mitchell, who had served for 11 years. This means that we have six 'new' trustees on the Board since 1 April 2008. We also have to anticipate one further replacement at the 2009 annual meeting, as the last of the original trustees, Tom Henderson, steps down. His is another example of sterling service, freely given.

Bearing in mind the changes in trustees, it is pleasing that there has been little change in membership of the advisory committees during the past year.

After a very committed stint as chairman of the dairy advisory committee, James Brown relinquished the chair in 2008 but remained on the committee until May 2009, where his experience was extremely valuable. John Thompson succeeded James in the role of chairman.

Harry Sinclair has stepped into the same position on the beef advisory committee, following the term served by Kenneth Sharkey. The place previously occupied by Colin Duffy on behalf of beef processors has been taken on by Liam

McCarthy.

On the sheep advisory committee, Jonathan Birnie has come forward to represent the processing sector in place of Lewis McClinton. After serving as scientific adviser on the sheep committee since the beginning, Moore Chestnutt retired in June this year. On behalf of AgriSearch, I wish to express thanks to Moore for his dedicated involvement.

Arrangements have been made to have a senior adviser from the College of Agriculture, Food and Rural Enterprise (CAFRE) on each of the committees, in a non-voting capacity. They are in a position to make well-informed input to the deliberations. The CAFRE representatives during the year were John Herron and Ian McCluggage.

On behalf of the trustees, I wish to thank all the members of these committees (listed elsewhere in this report) for their contribution to the work of AgriSearch. I also want to record thanks to Lynsay Alcorn for her efficient services as secretary to the committees and to David Mark as company secretary.

Notes to the financial statements for the year ended 31 March 2009

1. Accounting policies

These financial statements are prepared on the going concern basis under the historical cost convention and in accordance with the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" published in March 2005, the Companies (Northern Ireland) Order 1986 and applicable accounting standards. The principal accounting policies are set out below.

Tangible fixed assets

Tangible fixed assets are stated at cost less accumulated depreciation.

The cost of tangible fixed assets is their purchase cost, together with any incidental costs of acquisition. Depreciation is calculated so as to write off the cost, [or valuation], of tangible fixed assets, less their estimated residual values, on a straight line basis over the expected useful economic lives of the assets concerned. The orincipal annual rates used are as follows:

Computer equipment 20% straight line

Incoming resources

Income represents all monies, on an accruals basis, collected on behalf of the Company by its agents. The levy rates charged to producers are as follows:-

Milk - 0.02p per litre Beef - 20p per head Sheep - 5p per head

Resources expended

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category.

Direct programme expenditure

Direct programme expenditure represents research and development grants approved for payment. These are charged as expenditure in the year in which the commitment is made and are carried forward as a liability until paid.

Management and administration expenditure

This represents costs incurred in the management of the company's assets, organisational administration and compliance with constitutional and statutory requirements and other support functions.

Value Added Tax

The Company is not registered for VAT purposes; therefore expenditure is shown gross of VAT.

Unrestricted Funds

Unrestricted funds are amounts received or generated and which are expendable at the discretion of the Company in furtherance of its objectives.

Investment Income

Investment income is recognised on a receivable basis and arises from interest bearing deposit accounts.
