Term:	Trustees are elected for a three-year term and may serve no more than three consecutive terms

### About the organisation

AgriSearch (The Northern Ireland Agricultural Research and Development Council) is an independent charity incorporated as a company limited by guarantee.

AgriSearch was formed in 1997 to help dairy, beef and sheep farmers become directly involved with production-oriented research. The funds contributed by farmers to AgriSearch (through a voluntary levy collected by Dairy and Red Meat Processors) are used to commission research that will improve and develop beef, sheep and dairy farming in Northern Ireland.

In recent years AgriSearch's role has grown from merely being a co-funder of research to taking a much more active role in leading projects and acting as a liaison between researchers, advisors and the industry. It now has a pivotal role within the research and knowledge transfer functions for Northern Ireland's ruminant livestock sector.

#### Introduction

The Trustees are responsible for ensuring that the organisation runs according to its constitution and that the financial management of the organization is sound. The Trustee has considerable influence over the strategy of an organisation and is an important component of its effectiveness.

Currently AgriSearch's Board has an under-representation of women, so applications are particularly welcomed from this group.
